## BY-LAW V

### **ELECTION OF BOARD VICE-CHAIR**

- 1. The election of Vice-Chair shall be conducted in accordance with the procedure established for election of the Chair.
- 2. The procedure for the election of the Vice Chair is:
  - 1.1 The Supervisory Officer shall preside over the meeting until the Vice Chair is elected.
  - 1.2 Written nominations for the position of Vice Chair must be submitted to the Supervisory Officer by a date in time designated by the Supervisory Officer within no less than 3 business days prior to the meeting date set for election.
  - 1.3 The Supervisory Officer shall contact each nominee no less than one day prior to the meeting date to determine if each nominee is willing to stand for election.
  - 1.4 When only one person elects to stand for Vice Chair, that member shall be declared elected by acclamation.
  - 1.5 When more than one person elects to stand, the Supervisory Officer will confirm with each nominee whether he/she wishes to accept or decline the nomination, after which a vote shall be taken by secret ballot.
    - 1.5.1 The Supervisory Officer shall preside over the vote.
    - 1.5.2 The Supervisory Officer shall present each Trustee with a ballot containing the names of the nominees.
    - 1.5.3 When each Trustee has completed the ballot, the Supervisory Officer and Manager of Finance and Treasurer or Administrative Assistant shall collect all ballots and tally the votes in secret.
